1. Call to Order

The meeting was called to order by Chairman Pyburn at 1:04 p.m.

2. Certification of Posting of Notice

Certification of the posting of the notice as listed in the agenda was acknowledged. Dr. Albrecht certified that a notice of the meeting was posted in accordance with Title 5, Chapter 551, <u>Texas Government Code</u>.

Review of College Proposed Maintenance and Operations Budget 2018-19

Mr. Karl Stager presented the proposed Budget for 2018-19. Each Executive Leadership Team member gave explanation as to the difference of costs in their areas for the new year. In a PowerPoint, Mr. Stager explained how ACC is funded, how the change in estimated tax value affects the budget, various changes in the costs for benefits, proposed salary changes, potential tax rollback rate, and how the impact of a Maintenance Tax note would affect the budget not only next year, but for the next 20 years. Mr. Stager and Dr. Albrecht answered Regent's questions in the discussion phase of the meeting.

Maintenance Tax Note Discussion with Estrada Hinojosa

Mr. Dave Gordon Estrada, Hinajosa, presented the Board of Regents information on the approximate financing costs of a Maintenance Tax Note and answered any questions. Mr. Karl Stager presented two cost scenarios of proposed projects and their estimated costs that would be completed under a Maintenance Tax Note. The Board will further evaluate the list of projects and determine if additional items may be needed or deleted from the list.

Chairman Pyburn and Regents gave Mr. Dave Gordon permission to begin the processing of a Maintenance Tax note for a preliminary amount of \$25 million dollars and that after all the final values and interest rates are established, the Board could then adjust the total amount of the note to an amount that would be most affordable to the college. Mr. Gordon stated that he would begin the process and have ready for presentation at the June 28, 2018 Board of Regents meeting for consideration.

Review Board Operating Procedures

Chairman Pyburn and Regents confirmed that the Board Operating Procedures will be placed on the June 28, 2018 Board meeting agenda.

Board Self Evaluation

Ms. Sarah Langlois passed out self-evaluations to each Board Regent. The due date for completion and return to Ms. Langlois, either by email or regular mail, is July 2, 2018.
