

ALVIN COLLEGE
TAXPAYER IMPACT STATEMENT

House Bill 1522, passed by the Texas Legislature in 2025, requires the notice of a meeting at which a governmental body will discuss or adopt a budget to include a taxpayer impact statement showing, for the median-valued homestead property, a comparison of the property tax bill in dollars pertaining to the property for the current fiscal year to an estimate of the property tax bill in dollars for the same property for the upcoming fiscal year.

Alvin College (the College) has proposed a budget for the College's 2026–2027 fiscal year. Pursuant to H.B. 1522, the College provides the following information:

Median-Valued Homestead Property: \$365,550

Scenario	Tax Rate	Estimated Tax Bill
Prior Year (FY 2025–2026)	0.156543	\$572.24
No-New-Revenue (FY 2026–2027)	0.154953	\$566.43
Proposed Budget (FY 2026–2027)	0.162500 (PRELIMINARY)	\$594.02

The estimates in this taxpayer impact statement are based on the proposed budget and proposed tax rate that the College's Board of Regents (the Board) will discuss at its meeting on August 10, 2026. The proposed budget and the proposed tax rate may be amended by the Board before their final adoption. If the Board delays adoption to a subsequent board meeting and makes any amendments, the College will issue an updated statement.
