ACC Appeal Process:

- 1. Complete the Financial Aid Appeal Form.
- 2. Type your answers to the Required Appeal Questions on a separate document, and attach supporting documentation for your answers.
- 3. Submit the Financial Aid Appeal Form, typed answers to the Required Questions, and supporting documentation to the ACC Financial Aid Office email: FA@alvincollege.edu (pictures of the forms and documents are accepted).
- 4. The Financial Aid Office will contact your ACC Pathways Advisor to complete an Advising Program

 Assessment. The results of the assessment will be sent to your ACC email address and the

 Financial Aid Office.***
 - ***An Advising Assessment is not required for students accepted into selective admissions programs. Selective admissions programs include: Diagnostic Cardiovascular Sonography, Emergency Medical Technology (technician and paramedic), Health Information Management, Neurodiagnostic Technology, Nursing (ADN, LVN, and LVN-ADN Transition), Polysomnography, Respiratory Care, and Basic Law Enforcement Academy.
- 5. The ACC Financial Aid Office will review your appeal, supporting documentation, and Advising Program Assessment. Appeal decisions may take up to three weeks. Appeal decisions are sent via email. We recommend that students consider setting up a payment plan with the ACC Business Office if ample time is not allowed for your appeal to be reviewed.
- 6. Approved students will receive an Academic Plan via email. The Academic Plan must be adhered to by the student in order to maintain financial aid eligibility. Failure to adhere to the Academic Plan will result in the student forfeiting his/her financial aid eligibility. Financial aid cannot be disbursed until a complete and signed Academic Plan is on file with the ACC Financial Aid Office.
